Otherwise it shall be considered as a big entity. Applicant shall be presumed a big entity except when a sworn statement is submitted claiming the contrary.
- **Legal research fee with 1% of the total remitted amount but in no case shall it be less than PhPs 2.00.
- No advance payment for annual fees is acceptable, except only those made within 3 months before the due date.
- Increase in fees and charges, as may be warranted by the circumstances, shall immediately be due and payable, upon written notice thereof.
